3. Which service will we provide you with?

We will advise and make a recommendation for you after we have assessed your needs for Pleasure Craft Insurance, Commercial Hull Insurance, Commercial Liability Insurance, Yacht Owners Liability Insurance and associated insurances.

4. What will you have to pay us for this service?

There is normally no charge for our services.

You will receive a quotation which will tell you about any other fees relating to any particular insurance policy.
